

Privacy Policy of Solaputi Kids' Camp

Handling of Personal Data

The Public Interest Incorporated Foundation Solaputi Kids' Camp (also referred to as "we" "Solaputi Kids' Camp" or "us") recognizes the importance of personal data and handles it with the utmost care and protection.

This Privacy Policy applies to the handling of personal data obtained from each applicant and participant located in the European Economic Area (EEA) in the case of organizing events and camps organized by us.

1. Types of personal data

In this Privacy Policy, personal data means any data relating to an identified or identifiable natural person. We may collect and process the following types of personal data. Please note that some of the following types of data may not fall under personal data under the applicable law, depending on the contents thereof.

(1) When applying to participate in the events or camps hosted by Solaputi Kids' Camp

When an applicant applies an event, camp, etc. organized by us, we collect and process personal data provided by the applicant, including the applicant's name, gender, date of birth, age, address, telephone number, cell phone number, e-mail address, nationality, passport number (for overseas entries), and emergency contact name, telephone number and relationship to the applicant.

(2) When participating in events, camps, etc. hosted by Solaputi Kids' Camp

- Personal data to be provided by participants

If a participant suffers an injury and receives medical care, we will collect and process the necessary data, such as name and phone number, current illnesses being treated, current medications and allergies, name of the injury or illness, symptoms, place of occurrence and details of treatment (if any). Furthermore, if the participant is transported to a hospital, we will provide such data to the hospital.

- Personal data to be obtained from hospitals

If a participant is transported to a hospital, we collect and process data from the hospital such the name of the injury or illness, the course of symptoms, the course of treatment, and the

current prescription for the purpose of responding to the accident, including indemnity, and considering and improving the deployment of first-aid staff, number of emergency vehicles, and other safety-related matters at the next event or camp organized by us. We will obtain information from the hospital.

2. Compliance with statutory and regulatory obligations and all applicable laws

We strive to use and strictly manage the personal data we collect, use, and disclose in compliance with the Solaputi Kids' Camp's privacy protection regulations, which comply with. Whenever Solaputi needs to obtain, use, or provide personal data, it will comply with the EU General Data Protection Regulation (GDPR) and other relevant laws and regulations.

3. Acquisition, use and disclosure of personal data

Whenever we need to collect, use, or disclose personal data, it will do so under strict control and in compliance with Solaputi's personal information protection management system, which conforms to the Japanese Industrial Standard "Requirements for Personal Information Protection Management Systems" (JIS Q 15001:2006).

The purposes for collecting and processing personal data are specified in advance, and the We limit the collection and processing of personal data to what is necessary to achieve the purposes previously advised to applicants/participants.

(1) Purpose of handling personal data

We process the personal data of applicants and participants individually or for the purposes specified below.

- To apply for events, camps, etc. hosted by Solaputi Kids' Camp
- To select and register participants
- To improve service and safety for applicants and participants of events and camps hosted by Solaputi Kids' Camp
- To provide information from sponsors, cooperating companies, and related organizations
- To provide to the third parties as set forth in this Privacy Policy
- To participate in events, camps, etc. hosted by Solaputi Kids' Camp

In addition to the above purposes, for the following purposes

- To identify of participants
- To send of participation information, notification of records and related information

- To subscribe to insurance
- To provide medical care
- To provide support in the wake of an accident, including the Post-accident handling, including indemnity
- To examine and improve the places for distributing first aid staffing, number and location of emergency vehicles, and other safety issues at our future event, camp, etc.
- To implement and operation of other events, camps, etc. organized by Solaputi Kids' Camp
- To implement statistical survey on events, camps, etc. organized by Solaputi Kids' Camp

(2) Additional processing

When the personal data of applicants and participants is handled for purposes other than those listed above, we will notify each applicant and participant in advance of such additional purposes of handling and of any other matters required by the relevant laws and regulations.

(3) Consent

In principle, Solaputi Kids' Camp will process applicants' and participants' personal data based on their consent to this Privacy Policy. Applicants and participants may withdraw the consent at any time. However, this will not affect the legal validity of any processing of personal data made prior to the withdrawal of the consent.

We always obtain the consent of a parent or guardian, or consent with the permission of a parent or guardian, before acquiring personal data from applicants or participants under 20 years of age. If you are under 20 years of age, please have your parent or guardian consent to the use of our services (including, but not limited to, application and participation in our events, camps, etc.) before you use the services.

(4) Necessity of providing personal data

The personal data provided by applicants and participants is necessary for Solaputi Kids' Camp to provide services to applicants and participants, and applicants and participants who do not provide such data may not be able to use the services.

(5) Retention period

Solaputi Kids' Camp will retain applicants' and participants' personal data as long as it is necessary to provide services to them, but we will promptly delete it when it is no longer needed.

(6) Transfer of personal data

Solaputi provides applicants' and participants' personal data to third parties, including our subsidiaries and affiliates, our contractors such as cloud vendors and service operators, and hospitals, who will process applicants' and participants' personal data for the purposes specified above.

As a result, personal data of applicants and participants may be provided to persons located in countries or jurisdictions outside the EEA (including but not limited to Japan and the United States of America). Please note that such countries or jurisdictions may not have the same data protection laws as the EEA and may not afford data subjects many of the rights available to data subjects in the EEA.

The personal data of applicants and participants is provided to third parties located in countries outside the EEA, Solaputi will ensure that adequate measures are taken to protect the personal data of applicants and participants by, for example, entering standard contractual clauses based on the EU General Data Protection Regulation.

(7) Sensitive data

The health and medical information described in 1(2) above will be handled only to the extent necessary for the provision of medical care services, post-accident response including indemnity, deployment of first aid staff at the next event or camp organized by Solaputi Kids' Camp, number and location of emergency vehicles, and other safety-related matters.

4. Prevention of leakage, falsification, loss or damage of personal data

In handling personal data, we shall endeavor to store and manage personal data in an accurate and up-to-date manner, and will prevent leakage, loss, damage, or falsification of personal data by implementing Solaputi's security measures, and safely store and maintain personal data under strict control.

In addition, we will appropriately supervise employees who handle personal data and contractors to whom we entrusts the handling of personal data.

5. Continuous improvement of the personal data protection management system

Solaputi will continuously improve its personal information protection management system.

6. Rights of applicants and participants

The applicants and participants may request access to, correction or erasure of, or restriction of the handling of, or data portability of personal data held by Solaputi on applicants and participants.

The applicant or participant has the right to object to the processing of personal data relating to him or her to Solaputi or to the data protection authority having jurisdiction over the applicant's or participant's place of residence.

Requests for disclosure, correction, or discontinuance of use of personal information held by Solaputi Kids' Camp will be accepted in the manner prescribed in Solaputi's regulations.
